Mr. Alex asked if all of the notice requirements of Section 121.22 of the Ohio Revised Code and the rules of the Board regarding open meetings had been met. Mr. Moloney confirmed that all of those requirements and rules had been met.

2024 Budget Discussion

Mr. Moloney presented the 2024 Budget and Annual Report. The budget was discussed in detail.

Mr. Moloney reviewed accomplishments of 2023, including the ground breaking on a new canopy walk at Blacklick Woods and construction at two new parks; Great Southern and Bank Run. He thanked staff for their dedication in the many achievements in 2023, which included expanded visitor experiences, creative projects improved water quality. Over twelve million people have visited a Metro Park in 2023.

Mr. Moloney stated that a focus for 2024 will be working to accomplish several levy initiatives with a focus on additional trail connections, staffing improvements, improvements to existing park facilities and land acquisition.

Mr. McGivern provided a summary on the highlights for the 2024 budget. He mentioned the five-year forecast for revenue and expenditures will be positive through 2029, 5% annual growth in visitation and taking steps to reduce costs while increasing revenues. He also stated the value of Metro Parks in relationship to other park agencies and Franklin County agencies.

The Board thanked and commended staff for their leadership in 2023. They also asked several question relating to trail development and long-term maintenance, programs for diversity populations with continued growth in Central Ohio, land acquisition during the levy period and staffing levels.

 The Board authorized Metro Parks to enter into change orders with Brecks Paving for additional work on the Cherrybottom Road trail connection project at Blendon Woods Metro Park.
- #6125 AUTHORIZING ENTERING INTO A CONTRACT FOR PAVING IMPROVEMENTS AT BANK RUN METRO PARK UTILIZING THE STATE OF OHIO COOPERATIVE PURCHASING PROGRAM WITH THE OHIO DEPARTMENT OF TRANSPORTATION

 The Board authorized Metro Parks to contract with Kokosing Construction Company for paving improvements at Bank Run Metro Park using the State 101G Contract.

Staff will be hosting a preview tour of Bank Run Metro Park to Friends of Metro Parks members at 10:00am on Friday, November 26. Mr. Moloney invited the Board to attend this program.
