**Staff Reports**

**Administration**

Tim Moloney provided administrative updates. He met with COTA to discuss potential



LinkUs projects relating to the Heritage Trail Extension Project. He also met with Columbus Recreation and Parks to discuss potential involvement with their Art in Parks program.

Mr. Moloney also attended the premiere of ODNR's 'Wild at Heart' movie. It was an exceptional experience and has inspired us to do something similar.

### **Operations**

Bryan Knowles, Public Gardens Manager, introduced the Inniswood Staff. Inniswood has 300 volunteers, many of whom are helping overwinter the tropical plants in the greenhouse. They also plan on propagating 2,000 plants in Spring.

Larry Peck also provided updates from the district. Metro Parks weathered the first winter storms, pun intended. Sledding hills are open. Blendon Woods Nature Center Displays are being installed. Mr. Peck concluded that Metro Parks is ready for 2026.

### **Finance**

Rick McGivern updated the Board on the Finance Department. In November, revenues were above and expenditures were below. Deadline for 2025 payments is coming up. Two payroll periods were processed in November.

### **Human Resources**

J.J. Domiano provided updates from the Human Resources Department. 16 external staff have been hired, along with five internal promotions. Interviews for the Slate Run Farm position will take place this week. This position will focus less on education and interpretation and more on the actual labor of farming.

Breakfast with Santa was exceptional this year. 150 staff and family members enjoyed what Mr. Domiano calls, "the best blueberry pancakes ever."


#### **#6292 REQUESTING TAX ADVANCES FOR 2026**

The Board approved the request for the County Auditor and County Treasurer to make tax advances to the district for the 2026 calendar year.

#### **#6263 AUTHORIZING THE PURCHASE OF VEHICLES FROM BYERS FORD**

The Board approved the purchase of five vehicles from Byers Ford in the amount of approximately \$497,000 and further authorize expenditure of additional funds as needed to complete the transaction.
